



**NOTICE OF STATUTORY  
PUBLIC MEETING  
REGARDING DEVELOPMENT  
CHARGES AMENDMENT**

Take notice that Township of Mapleton Council is holding a public meeting on **August 13, 2024 at 7:00 PM** to discuss a proposed Development Charge amendment to By-law 2024-033. Council will consider approval of the amendment immediately following this public meeting.

Development Charges are fees on new developments that fund growth-related costs to a municipality which are governed by the *Development Charges Act, 1997*. A Development Charges Background Study, released on May 10, 2024, relates to the provision of eligible DC Services which includes Fire Protection Services, Parks and Recreation, Development-Related Studies, Services Related to a Highway: Roads and Related, Water Services, and Wastewater Services.

The Public Meeting is an opportunity for the public to review and provide comments on a proposed amendment to the Development Charges By-law 2024-033 that would impose residential development charges on wind turbines and telecommunications towers with respect to the following services: Services Related to a Highway, Fire Protection Services, and Development-Related Studies.

All interested parties are invited to attend the Public Meeting in-person or view (only) electronically.
