LOCATION OF THE SUBJECT PROPERTY is described as Part Lot 19 PT RD, PEEL CON 8, and is Municipally known as 7276 Eighth Line. The subject property has an area of approximately 0.53 ha (1.30 ac). The location of the subject land is shown on the map below.

THE PURPOSE AND EFFECT OF THE APPLICATION is to provide relief from the front yard setback requirements. The applicants are proposing to expand their existing home and construct a 193.4m² (2028ft²) new addition with an attached garage. The proposed variance is being requested in order to permit a reduced front yard setback of 9.15m (30ft). Other variances may be considered where deemed appropriate.

Any person or public body is entitled to attend this public hearing to provide comments in support or opposition, regarding the application.
