LOCATION OF THE SUBJECT PROPERTY is described as Pt Lot 9, Concession 10, RP 60R3006 Pt 4,8 and 12, municipally known as 7168 Wellington Rd 10. The subject property has an area of approximately 71.39 ha (176.4 ac). The location of the subject land is shown on the map below.

THE PURPOSE AND EFFECT OF THE APPLICATION is to provide relief from the Minimum Distance Separation II (MDS II) setback requirements. The applicants are proposing to construct a new dairy barn and storage for liquid manure on the subject lands. Other variances may be considered where deemed appropriate.
