**LOCATION OF THE SUBJECT PROPERTY** is described as Part Lot 11, Concession 14 (Maryborough) and is Municipally known as 8309 Wellington Rd 7. The subject property is 24.7 acres (10 ha) and is occupied by a residence and manufacturing of agricultural buildings and general use sheds (Denco Storage). The location of the subject land is shown on the map below.

**THE PURPOSE AND EFFECT OF THE APPLICATION** is to provide relief from the sitespecific exemption on the property that limits the size and number of the buildings associated with the shed manufacturing. The applicants are proposing to remove some of the smaller buildings and replace them with a larger structure that will exceed the overall permitted floor area maximum. The building is required to accommodate material and equipment storage. Other variances may be considered where deemed appropriate.

Any person or public body is entitled to attend this public hearing to provide comments in support or opposition, regarding the application. If you are unable to attend, you may submit your comments in writing prior to the meeting date to the Secretary Treasurer of the Committee of Adjustment.
