



## NOTICE PROVISION

### FEES AND CHARGES

**TAKE NOTICE** that the Township of Mapleton water and wastewater rates have been reviewed. In order to maintain the sustainability of the current system and to provide for required future capital improvements, Council has revised the existing water and wastewater rates. The new rate changes will take effect August 1, 2020.

**What does this mean?** Effective August 1, 2020, the rate structure has been revised to increase the base charges and decrease the volumetric charges.

**How much will the rates change for 2020?**

**How will this affect bi-monthly bills?** A residential household in Drayton, with a standard sized 5/8" water meter that uses 23 cubic metres of water per two-month billing cycle would see their bill change as follows:
