LOCATION OF THE SUBJECT PROPERTY is described as Lot 18, Concession 3 and is Municipally known as 7311 Third Line. The subject property has an area of approximately 38.06 ha (94.05 ac). The location of the subject land is shown on the map below.

THE PURPOSE AND EFFECT OF THE APPLICATION is to provide relief from the Minimum Distance Separation II (MDS II) setback requirements. The applicants are proposing to construct a storage for liquid manure on the subject lands. Other variances may be considered where deemed appropriate.
