APPLICATION FOR KENNEL LICENSE

INTRODUCTION

New Applications - All individuals wanting to operate a kennel in the Township of Mapleton must first complete a Zoning By-law Amendment Application and Site Plan Control Application. Once the applicant has successfully completed these processes, the following application is to be submitted for approval and pay the required fee. Township staff will review your application to ensure that all information has been completed.

Following the completion of an approved kennel license application, the Township's Canine Control Officer will contact the property owner to conduct an inspection of the property. No kennel license shall be granted unless all terms and provisions of the Township's by-law to license and regulate dogs and dog kennels have been complied with.

Renewal Applications - All existing licensed kennel owners must apply each year to renew their license. No kennel license shall be renewed unless all terms and provisions of the Township's By-law to license and regulate dogs and dog kennels have been complied with and the kennel license fee has been paid.
