MUNICIPAL CLASS ENVIRONMENTAL ASSESSMENT FOR MAPLETON WASTEWATER SERVICING

NOTICE OF COMPLETION OF ENVIRONMENTAL STUDY REPORT

The Township of Mapleton completed a Municipal Class Environmental Assessment (Class EA) to evaluate alternatives to expand the treatment capacity of the Mapleton Wastewater Pollution Control Plant (WPCP), located on Sideroad 15, Drayton, and to upgrade the wastewater collection system. The study was completed to ensure the Township's WPCP and wastewater conveyance system would have sufficient capacity to accommodate expected growth in the communities of Moorefield and Drayton.

The study was conducted in accordance with Schedule C of the Municipal Class Environmental Assessment process (October 2000, amended 2007, 2011 and 2015), which is approved under the Ontario Environmental Assessment Act. The Environmental Study Report (ESR) has been completed and by this Notice is being placed in the public record for review and comment. Subject to comments received as a result of this Notice and the receipt of necessary approvals, the Township intends to proceed with implementation of this project.
